- Start the trimmer/brushcutter from both hot and cold start in a safe manner
- Carry out pre-cutting checks
- State the possible hazards/risks when carrying out maintenance or operational tasks
- Maintain the trimmer/brushcutter and cutting heads in a safe and efficient working condition
- Adjust the equipment for safe and comfortable operation
- Select the correct cutting head for the relevant operating conditions
